## **Prospectus for Admission to the B.Ed. Degree Course in Sree Narayana Training College, Nedunganda, affiliated to the University of Kerala for the academic year 2026-'27**

Sree Narayana Training College, Nedunganda is affiliated to the University of Kerala and accredited by NAAC with Grade A. In the college, admissions are made by strictly adhering to the rules and regulations issued by the University for the B.Ed. course. The admission procedure is conducted by the college as per the rank list of the candidates prepared by the University, which is based on the online registration of students in the University admission portal and the submission of applications online.

### **1. INTRODUCTION**

- 1.1. Prospectus for admission to the B.Ed. Degree Course in Sree Narayana Training College, Nedunganda, for the academic year 2026-'27, as approved by the University of Kerala, is published herewith. It contains general information and rules relating to the admission to the B.Ed. Course 2026-'27.
- 1.2. The prospectus issued during the previous years is not valid for the year 2026-'27.
- 1.3. Admissions shall be made by the college as per the rank list prepared by the University on the basis of the marks obtained in the qualifying examination.

**Applications to the B.Ed. Degree Course shall be submitted in the online mode. Any candidate who desires to obtain admission under the University of Kerala for the B.Ed. Degree Course, should compulsorily register online before the closure of registration, irrespective of the Category (Open Merit (General) /SEBC/ EWS/ SC/ST/ Community /Management / Candidate from Union Territory of Lakshadweep/ Differently Abled Persons /Defence Quota/Teachers Quota/Sports Quota/Tamil Linguistic Minority etc.) to which he/she belongs.**

### **2. ACADEMIC ELIGIBILITY (General)**

- 2.1. Candidates should have passed the B.A./ B.Sc. Degree Examination under the 10+2+3 pattern from the University of Kerala or any other University recognised by the University of Kerala.
- 2.2. Candidates who have passed their qualifying examination from universities other than the University of Kerala should submit Eligibility/ Equivalency Certificate stating that their qualifying examination is recognised by the University of Kerala for seeking admission to B.Ed. Degree Course in a particular optional subject in a stream as applicable, along with their application.
- 2.3. Double or Triple main candidates or candidates who have passed the Degree Examination in Vocational or Specialised Courses are also eligible for admission. However, they have to submit copy of their Eligibility/ Equivalency Certificate from the University of Kerala stating that their qualifying examination is recognised by the Universities for seeking

- admission to B.Ed. Degree Course in a particular optional subject in a stream as applicable, along with their application.
- 2.4. The minimum requirement of marks for admission to B.Ed. Degree Courses is 50% for Part III/ 50% in aggregate (Parts I+II+III together) in Bachelors' Degree (Science/ Arts Subjects) or 50% marks in post-graduation in the concerned subject.
  - 2.5. Ranking of candidates shall be on the basis of marks obtained for Part III.
  - 2.6. Rounding off the percentage of marks to the nearest whole number is not permitted.
  - 2.7. **Academic Eligibility should be satisfied as on the last date for submission of application.**

### 3. RELAXATION IN MARKS

---

- 3.1. Candidates belonging to the Scheduled Castes/ Scheduled Tribes (SC/ ST) communities with pass, for Graduation and Post-Graduation in the respective optional subjects, are eligible for admission.
- 3.2. Candidates belonging to the Socially and Educationally Backward Communities (SEBC) will be given 5% concession
- 3.3. Candidates belonging to the Other Eligible Communities (OEC) will be give 5% concession.
- 3.4. Blind candidates will be given 5% concession. (G.O.(Rt) No. 301/10/H.Edn dated 10-02-2010).

### 4. CHOICE OF OPTIONAL SUBJECTS

---

- 4.1. The optional subject for the B.Ed. course should be the same as one, which the student has selected as main subject for graduation, or the main subject for graduation conventionally recognized to be coming under the optional chosen. In case, the main subject is different from or conventionally considered as not coming under the optional opted for admission, a copy of the Certificate from the University of Kerala, stating that such degree is eligible for admission to that optional for B.Ed. course, should be furnished along with the application.
- 4.2. Eligibility for Different Optional Subjects: Candidates seeking admission to the B.Ed. course in a subject/stream will have to satisfy the academic eligibility applicable to the subject/stream.
- 4.3. **Optional Subjects offered in the college: English, Malayalam, Mathematics, Physical Science, Natural Science and Social Science.**
- 4.4. **Total number of seats: 110 (including 10% seats reserved for the EWS category)**

## 5. HOW TO APPLY

---

- 5.1. Any candidate who wishes to join the B.Ed. programme in the college should compulsorily register online at <http://admissions.keralauniversity.ac.in>  
(The detailed steps for the online registration process are provided in the University Prospectus)

## 6. ADMISSION PROCEDURE

---

- 6.1. After completion of the registration process, the University prepares rank list of the candidates from the applications submitted. The same will be published in the profile of the candidates and in the college login.
- 6.2. The candidates in the rank list have to report before the principal of the college concerned and appear for certificate verification and admission thereafter, if eligible, on the dates notified for admission, with the documents mentioned in 7.
- 6.3. The principal of the college ensures that the candidates are eligible at the time of admission itself.
- 6.4. The college collects the fee due to the University from the candidates at the time of admission itself and the same is remitted to KUF. (Details of fee due to the University is given in clause 12 in the University Prospectus)
- 6.5. The qualifying certificates and all other necessary documents are forwarded to the University within 15 days from the date of closure of admission.
- 6.6. After completing the verification, the enrollment of the eligible candidates will be done within a period of one month. Only such candidates will be permitted to appear for the examination.

## 7. CERTIFICATES/ DOCUMENTS TO BE SUBMITTED

---

- 7.1. Print out of completed online application.
- 7.2. The original fee receipts of Registration fee and University fee.
- 7.3. Original and a self-attested photocopy of the SSLC or any relevant school records to prove date of birth.
- 7.4. Original and a self-attested photocopy of the mark lists of all parts of the qualifying examination(s) and Degree/ Provisional certificate.
- 7.5. Certificate to prove nativity, if applicable.
- 7.6. TC from the institution last attended.
- 7.7. Course and Conduct Certificate.
- 7.8. Migration Certificate from the University last studied.
- 7.9. Certificates from the village officer namely “The applicant belonging to Anthyodaya Anna Yojana (AAY) and Priority Household (PHH) category” or “The income or assets certificate for Economically Weaker Sections (EWSs) in General Category” for candidates under EWS category.
- 7.10. Caste/Community Certificate for candidates under Scheduled Castes/

Scheduled Tribes quota.

- 7.11. Original certificates in support of Special reservation, if applicable.
- 7.12. Original and a copy of the Equivalency Certificate and Eligibility Certificate from the University of Kerala, specifically stating that, their Qualifying examination is recognized for seeking admission to B.Ed. Degree course (not Higher Studies/ Employment purpose) in a particular optional subject/in a stream as applicable, in case of double or triple main candidates/ or candidates who have passed the degree examination in Vocational or specialized courses.
- 7.13. Original and a self-attested photocopy of NSS/NCC certificate at degree level, if applicable.
- 7.14. Undertaking from the students as per the provisions of anti-ragging verdict by the Hon'ble Supreme Court of India.
- 7.15. Declaration against dowry.
- 7.16. Photocopy of Aadhar card.
- 7.17. Passport size photographs (3 nos.)
- 7.18. Any other relevant certificate for any claim made in the application.

*If a candidate gets allotment in their higher options, the TC issuing institution shall issue the duly attested copy of the original TC (UG/PG/others) surrendered by the candidate, along with the TC issued by the institution concerned. When the original documents are forwarded to the University for verification, the copy of this original TC of the candidate may also be forwarded.*

## **8. WEIGHTAGE/ DEDUCTION**

---

- 8.1. 15 marks will be given to candidates who have First Class PG Degree, 10 marks for Second Class PG Degree, 5 marks for Third Class PG Degree in the same subject for which the candidate seeks admission. Weightage for PG marks will be given to candidates only where minimum qualification is graduation.
- 8.2. 10 marks each for certificate holders of National Service Scheme (NSS)/ National Cadet Corps (NCC) for participation in NSS/ NCC at the Degree level. Weightage marks will be added to the marks obtained in Part III of the qualifying examination.

## **9. GENERAL RULES AND CONDUCT FOR STUDENTS**

---

Once taken admission in the college, every student is directed to make it a part of his/her responsibility to attend classes daily and punctually. Students are expected to be in the multipurpose hall at the first bell and begin the day by reciting the common prayer. No student shall leave a class without the permission of the teacher. No student shall be seen outside the classroom during class hours. The general rules and conduct for students are listed:

- 9.1. Students should give due respect to teachers when they enter and leave the room by getting up and greeting the teachers.
- 9.2. No student will enter or leave the classroom when the session is going on without the permission of the teacher concerned.
- 9.3. Students are expected to spend their free hours in the Library/ Reading Rooms. They should not wander along the corridors or crowd at the gate or in front of the office.
- 9.4. Nothing is more appreciated in a student than courteous and good behaviour. Students should give due respect to teachers and the other staff of the college, and greet them inside and outside the campus.
- 9.5. Students are expected to be properly dressed. Showy clothes are to be avoided. Students are expected to show dignity in their dress and general behaviour.
- 9.6. Students are expected to keep their mobile phones in silent mode inside the campus.
- 9.7. Do not damage or disfigure the walls, doors, windows, furniture etc. (Learning not to damage property whether public or private) is one of the primary requirements for civilized behaviour.
- 9.8. Political activities are strictly banned in the campus. Students are forbidden to organize or attend meetings other than academic ones. Students resorting to strikes are strictly prohibited from entering the veranda of the building or the classrooms.
- 9.9. To submit complaints or grievances only the representatives should meet the principal.
- 9.10. Any student who violates the rules and regulations of the college will be subjected to strict disciplinary actions.
- 9.11. Students are required to wear College identity cards while in the campus.
