AMENDMENT TO THE KERALA UNIVERSITY FIRST ORDINANCES, 1978

IN exercise of the powers conferred on the Syndicate by virtue of Section 36 of the Kerala University Act, 1974, the Syndicate at its meeting held on 3-12-1994 made the following amendment to Chapter XIII THE Kerala University First Ordinances 1978 regarding work load and staff pattern of Teaching Staff of Arts, Science and Training Colleges substituting the present provision.

Staff pattern of Training Colleges:

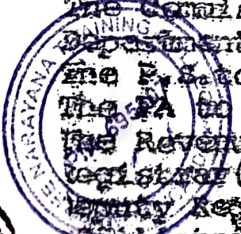
- 1. Principal : 1

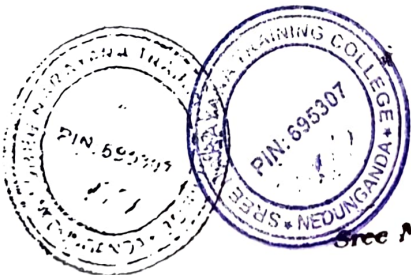

Sir,

Your institution was granted recognition with an intake of 100 vide recognition order dated F. SRO/NCTE/1999-2000/8055 dated 09.06.1999. On scrutiny of the Performance Appraisal Report submitted by you it is observed that the teacher pupil ratio of 1.12.5 is not maintained. This is gross violation of NCTE norms.


You are directed to appoint 3 more qualified teachers for an intake of 150 and submit documentary evidence regarding availability of staff as per NCTE norms of 1.12.5. Physical Education Teacher, Art and Music, Craft Teacher etc are not to be included as part of the core teaching staff.

As per the decision of SRC in its 76th meeting held on 24th & 25th June, 2004, you are required to strictly follow NCTE norms in respect of teaching staff by appointing the required staff to cover foundation and methodology subjects. Any violation in this regard may attract contempt of Kerala High Court directions.
